VAT Regulation changes in European Union

Since 1st of July 2021 European Union is announced new VAT regulations. This change mainly effects on buyers, who has no EU VAT number (private buyers). Until now, private buyers were not forced to pay VAT, but from now nobody is in exception. Please see background laws and rules:

There are 3 different typical cases, please study them below:

- 1.) If you are business owner in European Union (EU), you can buy the tool or service (software) from me by 0% VAT. But in your country, you must pay the VAT amount, based on your country's rules and percentages. This is not a new regulation, it was exactly same before the changes. Please note, I must report your VAT number and the order amount to local TAX office.
- 2.) If you are a private buyer in European Union (not a business owner) I must ask from you VAT payment, and I will pay this VAT amount into your country's TAX office, via a new electronic network system called OSS (One Shop Stop). This is a new regulation, which cause lot of additional work for me and extra payment for private buyers.
- 3.) If you are a buyer from outside of EU, you can buy the tool or service (software) from me by 0% VAT. But when the parcel arrives at your country, the Customs Office will ask from you to pay TAX, customs charges or maybe both. This is also not a new regulation, it was exactly same before the changes. Because service (software) is downloadable, not visible in parcel customs office at border, so remain 0% TAX and VAT, and I do not report this event to your country.

See below chart for case studies, on comparing format. As you see, everybody shall pay VAT or TAX somehow, outside of seller's location.

Only Hungary to Hungary payment is remained 0% for both parties, due to my business format.

Please select in web shop by correct way the items (including VAT or VAT free) according to your country and your business type. Please buy goods or services with EU VAT number indication in web shop if your VAT number is valid. We will cross check your validity in VIES database https://ec.europa.eu/taxation_customs/vies/?locale=en and ask VAT balance payment if your VAT number is invalid. If your EU VAT number is correct, invoice indication become 0% VAT. Please note, my country's VAT is the highest 27% in the EU, so you will pay in any other countries less amount.
